

TERMS AND CONDITIONS

JDL REWARDS TERMS AND CONDITIONS

ACCEPTANCE

The JDL Rewards Program is brought to You ("the Individual", "the Business") by Jade Lee Electric (Pty) Ltd T/A JDL Electric ("Us", "We", JDL).

These Terms and Conditions constitute an agreement between You and Us and govern Your and Our rights and obligations once You register for the JDL Rewards Program and/or each time You use the JDL Rewards Program. By using the JDL Rewards Program, You acknowledge that You have read, understood and agreed to these Terms and Conditions.

THE JDL REWARDS PROGRAM IS FOR FREE

The JDL Rewards Program is for free in that We will not charge You:

- to earn cash back;
- a joining fee; or
- any periodic or annual membership fees.

QUALIFICATION CRITERIA

To qualify for the JDL Rewards Program, You must:

- Have at least 20% (or more) growth in spend per annum with JDL Electric for each period running from 1 January to 31 December.
- Ensure that Your account with JDL Electric is up to date and within the agreed payment terms at all times.
- Attend and participate in the annual JDL function and follow us on any of our social media platforms for notifications.

When You meet all the criteria, You will be entitled to receive 1% in cash back on Your spend per annum.

PENALTY CRITERIA

In the event that You default payment on Your account, the following penalties will be enforced:

- 1st default: 20% penalty imposed on yearly cash back amount
- 2nd default: 50% penalty imposed on yearly cash back amount
- 3rd default: Your account will be reset to zero spend for the cash back percentage

JDL Rewards are not transferable. JDL Rewards benefits will accordingly accrue to the named member only.
